

RELEASE AND WAIVER OF LIABILITY & ACKNOWLEDGEMENT OF RISK ~ Bridge Academy / Second Branch Baptist Church

I hereby expressly assume all risks associated with my child's participation in any educational activity or recreational activity at Second Branch Baptist Church ("SBBC") under the guidance of Bridge Academy ("BA") and associated with Bridge Academy or SBBC. Educational and recreational activities may take place in a SBBC classroom, in the SBBC kitchen, or elsewhere on or off of the SBBC campus. Recreational and educational activities may include, but are not limited to, basketball, volleyball, or any other recreational or educational activity (hereinafter, all educational and recreational activities shall be referred to as "activity" or "activities"). My child's participation in any activity is completely voluntary. I am aware that my child's participation in any activity may pose potentially serious risks of injuries to my child or others.

I release any and all rights or claims for damages against Bridge Academy and/or SBBC, all employees, all agents and all individuals hosting the activities on behalf of Bridge Academy and/or SBBC, for any and all injuries, loss or damage my child may suffer during my child's participation in or my participation in or in any way connected with these activities.

I will hold harmless and fully indemnify Bridge Academy and SBBC employees, volunteers, agents, heirs and assigns from any and all claims, damages, actions, liability and expense now and in the future, in connection with any and all personal and bodily injury to me and my child including death and/or damage or theft to my personal property or my child's personal property in connection with my child's participation in any activity, be it foreseen or unforeseen.

I will hold harmless and fully indemnify Bridge Academy and SBBC for any property damage and for any personal injuries that my child may cause to others by their participation in any recreational activity.

This Release and Waiver / acknowledgement of risk shall remain valid unless expressly revoked by the parent or guardian of the child, in writing, with receipt acknowledged by an authorized agent of Second Branch Road, Chesterfield, Virginia 23838. If any provision of this Release and Waiver is deemed unenforceable by a court of law, the remaining provisions are severable and shall remain in full force and effect. This Waiver and Release is governed by the laws of the Commonwealth of Virginia.
